

# REA Members Briefing: Frequency Response Auction Trial

### Introduction

The UK Electricity System Operator (National Grid ESO) are reforming the various frequency response (FR) products. The Frequency Response procurement auction trial goes live from 25/26 April 2019. The REA has compiled this members-only briefing on the auction trial. This mechanism will help provide a route to market for distributed energy resources and energy storage as part of a suite of reformed balancing services from National Grid as ESO.

## Service Requirements

Participants must provide: At least 30 minutes' worth of capacity Response within at least 1 second Activation point is at 49.6 Hertz

Contracts will be allocated via a weekly auction. Initial registration is fairly straightforward, with two forms needing to be provided. The pre-qualification process is shown below:

<u>Form A</u>: Company information - this must be in the exact same format as the firm's details on Companies House.

This form effectively registers the organisation for the range of National Grid ESO (NG ESO) Balancing Services markets, if they wish to provide them (individual service opt ins also required). One form is required per parent company/agent or aggregator, which can have a sole Company Director signatory.

Form B: Registration of interest in providing specific FR Auction Trial service.

<u>Form C (to Applicants)</u>: NG ESO will send confirmation of acceptance onto the scheme via 'Form C' (but not confirmation of a FR auction contract – this depends on the auction outcomes)

Online Portal entry: Each company then provides the details of specific units participating in the auction via the Online portal.

Technical testing and verification: these are required prior to capacity delivery but it is unclear how this will operate/what will be required, at this stage.

NG ESO also say there will be a 'week by week' opportunity to pre-qualify for the auction even after the Go live date (details TBC).

## **Auction process**

Contracts will be allocated on a Pay-as-Clear basis - like the CfD mechanism - with bids stacked by lowest prices and assessed by their impact on the available capacity.

Auctions will be run on a weekly basis as follows:

10am Thursday – NG issue the volume to be procured and maximum price

12pm Thursday – Participants must lodge their final bids

12pm Friday – Results of the auction are published by NG

11pm Friday – Capacity must be delivered from this time
