



Manifesto Messaging

- our ambition

To do this;

- Renewable energy and clean technology to be market competitive and supported by policy
- The high carbon economy to embrace renewable energy and clean technologies in order to become sustainable
- Renewable energy and clean technology to deliver jobs across the country and those in fading industries to be re-skilled.

The REA's strength is that we look at the resource and energy landscape *as a whole* and how this impacts our members, from those who deliver a specific technology or solution, or those engaged in multi technologies across multi sectors.

Manifesto Messaging

- the problem

Currently, there are *too many examples* of policy being a blockage to the deployment of renewable energy and clean technologies across the UK.

- Heat and transport policies are in limbo and long-term direction is lacking
- Most renewable power including solar and onshore wind deployment has stalled
- A more 'flexible' energy sector is too slow to emerge
- Recycling and waste management is inconsistent across the UK
- Planning and consenting regimes are disorganised
- Building regulations do not fully incentivise energy efficiency, selfgeneration, and the low-carbon energy sector's vision of 'buildings' as power stations'
- The economy and general public are yet to fully understand the value of the transition to renewable energy and clean technology

The level of growth and technical development in the sector is astronomical.

This is very exciting, but it is challenging for the public sector and industries that must re-organise and modernise very quickly to decarbonise. Especially when the system change needed spans across multiple sectors and Government departments.

Ensure that the funding, integrated planning and delivery of the wholesale systems change that's needed to decarbonise the economy sits with No 10 and the Cabinet Office. An independent body with strong enforcement capabilities should be appointed to ensure the Government produces policy that supports decarbonisation in line with the Carbon Budgets and advice of the Committee on Climate Change.



The next Government must:

Ensure that renewable energy and clean technology are central to a Net Zero Treasury test, as set by Committee on Climate Change and enforced by an independent body, for Government funding; and that the Treasury implements a more effective taxation system that incentivises these technologies instead of fossil fuels.

The next Government must:

Reform Ofgem, in part by including decarbonisation as a central mandate, alongside consumer protection, and ensure energy network operators are sufficiently incentivised to modernise the energy systems so that they can deliver a major expansion of renewable energy generation capacity and meet the 5th Carbon Budget.

Help local authorities to reach Net Zero by providing ring-fenced funding for measuring and reporting on progress on the number of zero-carbon buildings, energy efficiency, effective waste management, decarbonising transport fleets while valuing soil quality and natural capital.

Deliver a just transition by developing a workforce strategy that supports the renewable energy and clean technology sector to provide high-quality skilled jobs for existing fossil fuel sector workers transitioning to the new economy, and future workers, across the UK.

- Collaborate with other organisations who are working to achieve the same aim in the climate change sector to organise a hustings.
- Develop a media angle for our manifesto calls, can we repurpose the REView 2019 data, find some case studies to demonstrate that the sector needs concerted support?

3.3 Local Campaigning

Meeting our objectives

- Create list of constituencies and identify PPCs with REA members
- Desk based research to allow us to segment by local issues, aligning with manifesto calls.
- Identify possible champions
- Support members to contact their PPCs and ask them to support the REA manifesto calls/champion us in Parliament.
- Provide template press statements to PPCs about renewable energy & clean tech
- A Twitter day of action, aligning with national 'moment', for PPCs to show their support for renewable energy & clean tech
