Freedom of Information Act 2000: Fuel duty

Thank you for your enquiry of 18 October 2019, which we have considered under the terms of the Freedom of Information Act 2000 (the FOI Act).

You asked for the following information:

"Please can you provide details for the years 2016, 2017, and 2018 on the amount of fuel duty collected from the use of Natural Gas (24.7p/kg duty rate) in transport.

In addition do you have the same figures for LPG use (31.7p/kg duty rate)?"

The information you have requested is available and in the public domain and can be found in the HMRC Hydrocarbon Oils Duties Bulletin:
