Hi Gaynor,

We are well all things considered, thank you for asking. I hope the same is true of you and your colleagues.

I'd like to apologise for the delay in getting back to you. I had thought that we responded to your follow up question but I now realise that not to be the case.

The Renewable & CHP Register rewrite project will look to replicate or improve all the existing functionality that is still relevant to administer the scheme. Currently, a station looking to decommission capacity will only be able to decommission the most recently approved capacity on the Renewables & CHP Register.

I believe that your question is still one that we are unable to answer without functioning outside of our administrative remit. Ofgem considers each application for accreditation/amendment to an existing accreditation on a case by case basis based on circumstances specific to the generating station in question.

I again appreciate that you are seeking certainty in respect of the generating stations described,

however, our remit as administrators of the scheme is not to provide legal nor technical advice to stakeholders, nor advice on how to fit their individual circumstances to the provisions of the ROO. We would encourage you/your members to seek such advice independently and make a case to us as to how you believe your proposals may meet the requirements of the legislation.

Capacity Trading

Facilitation of New Markets

In addition to directly procured DSO services, we need to consider how we can facilitate other markets that the DSO might be able to enable or support in the future (e.g. peer-to-peer trading platforms, capacity management, trading flexibility to take on or avoid constraints). Development work should include consideration of:

- Principles identified through WS1A P1 and proposals established through the Industry-Led
 Access Working Group's work on exchange of access
- What data needs to be provided to facilitate new markets,
- What data needs to be sent to network operators after any action/trade is made
- Trial scenarios that can help to develop and understand these markets and the required DSO
 actions to facilitate these

The deliverable will be a report outlining a best view on the types of non-DSO procured services and recommendations on actions required by the DSO and market participants for the facilitation of these markets
