

British Energy Security Strategy – REA View

- The REA welcomes commitments regarding solar, hydrogen and offshore wind, but the Energy Security Strategy locks the country into more expensive, longer to build, non-renewable power sources.
- The Government needed to turbocharge support for technologies which could tackle the cost of living crisis, and not just focus solely on developments which won't come to fruition for another 5, 10, 15 years.
- Refusal to expand Energy Company Obligation scheme will condemn people to continued financial hardship for the foreseeable future.
- No mention of biogas / green gas



Queen speech

On 10th May Prince Charles read out the UK Government's legislative plan for the next Parliamentary term (known as the 'Queen's Speech'). This included several pieces of draft legislation related to energy and Net Zero more broadly.

- A new **'Energy Security Bill**' to enact the 'British Energy Security Strategy' published last month the creation of the Future System Operator (FSO), annual CfD auctions, the review of electricity markets (REMA). CCUS support etc
- Confirmation of the UK Infrastructure Bank Bill and establishment of this new public body - Net Zero investments will be within its remit;
- Confirmed changes to **Pension fund investment rules** called for by REA and others and listed in our Strategy for the sector;
- A Leveling Up Bill that may include favourable changes to planning, while giving local people more say in the planning process (details TBC).

REA media campaigns (Q1 2022)


- Since the turn of the year, the REA media campaigns have largely centred around energy security and the cost of living;
- The REA's '6-point plan', culminating in an industry-wide letter, received wide-spread coverage, including in the Times;
- Media coverage was also secured in the Guardian, the i and the Daily Mail, in addition to a variety of trade publications;
- Further appearances on radio and podcasts, including Ed Miliband and Geoff Lloyd's 'Reasons to be Cheerful'.

Engagement with Government (Q1 2022)

- Meetings secured with Kwasi Kwarteng, Greg Hands and Trudy Harrison;
- REA communicating directly with Ministers on a number of issues, including deep geothermal, red diesel, contactless payments for EV charging, and Biomass Fuel Quality Standards, green gases.
- REA's red diesel campaign also saw engagement with MPs across the country, with James Sunderland and Jerome Mayhew meeting with REA members;
- REA preparing for Party Conferences and the 2022 Budget.
- Meeting with SoS Kwasi Kwarteng on 16th May – to discuss gaps in the BESS including bioenergy (incl biogases)





Business Rates

Autumn Statement 2021

"From 2023, the government will introduce exemptions for eligible plant and machinery used in onsite renewable energy generation and storage, and a new 100% relief for eligible heat networks, to support the decarbonisation of building."

Spring Statement 2022 – Government announced they would bring this measure forward to be implemented as of April 2022.

- Legislation has been laid to bring this into effect.
- Largest benefit will be seen by those who are using generation onsite, who previously saw high rateable values.
- Note that measure does not mean that Business Rates will be nil, just that rating bill will be reduced.
- Measure intended to stay in place until 31st March 2035
- We are still awaiting further guidance from the Valuation Office Authority (VOA) on the application of this measure.




- (b) after paragraph (d) insert—
 - "(e) "excepted renewables plant and machinery" means plant and machinery used or intended to be used for the generation, storage, transformation or transmission of power where the sources of energy or technologies relied upon are mainly or exclusively—
 - (i) biomass:
 - (ii) biofuels;
 - (iii) biogas;
 - (iv) fuel cells;
 - (v) photovoltaics;
 - (vi) water (including waves and tides);
 - (vii) wind;
 - (viii) solar power;
 - (ix) geothermal;
 - (x) heat from air, water or the ground;
 - (f) "excepted EVCP plant and machinery" means plant and machinery which is
 - (i) used or intended to be used mainly or exclusively for storage, transformation or transmission of power for an electric vehicle charging point (within the meaning of section 45EA(5) of the Capital Allowances Act 2001(2)); and
 - (ii) within head (d) or (e) of Table 1 below".

And what about degression?

- GGSS degression has not been active for the GGSS's first 6 months.
- The first possible degression will be on 1 July 2022, following BEIS' publication of the <u>Quarterly</u> <u>Expenditure Forecast Statement</u> on 1 June 2022. Max 10%.
- Similarly to the NDRHI, degression will apply if the forecast spend based on the number of applications that passed stage 2 as of 30th April 2022 hit the degression threshold (£ 81.24 million).
- We know from Ofgem's monthly report that only 7 applications have passed this stage as of 11th May (assuming ~ £3m per site, this is roughly £33million), making degression unlikely to apply on 1st July 2022.

Clarity provided by Defra on 'Food-grade' CO₂

- Over the last few months the REA, along with other stakeholders, had discussions with different Government departments on the security of supply of CO₂, the role of bio-CO₂ and barriers.
- During discussions with the relevant sectors across the CO₂ supply chain, Defra have <u>clarified</u> that:
 - ✓ Government supports the safe use of CO₂ in the food industry.
 - ✓ Any CO₂ that meets the classification of 'food-grade', as defined by the FSA via reference to the food additive specification in the Commission Regulation (EU) 231/2012, is suitable for use in the food sector, regardless of the source. Alternative specifications: ISBT and EIGA.
 - ✓ No regulatory or legislative concerns on CO_2 from waste or sewage management as long as it meets above specs.

EA have also <u>clarified</u> that:

- CO₂ recovered from biogas that meets the FSA foodgrade specifications would also in principle meet 'end of waste status' and would no longer be defined as waste.
- Companies can make this decision themselves, but if they want to be fully protected from the very low legal risks, they can:
 - ✓ At a site-by-site basis make use of the EA's EoW service which will review whether this position is correct
 - ✓ At an industry scale, put in place a Resource Framework (ie *Quality Protocol*) to confirm the process will always meet end of waste requirements:
 - Review the existing Quality Protocol for biomethane – easiest route;
 - Create a new dedicated Protocol.



Clarity provided by EA on regulatory regime for CO₂ capture and storage

On 27th April, EA published a <u>regulatory position statement (RPS)</u> setting the EA's enforcement position on CO₂ from AD that meets <u>food and beverage</u> or <u>industrial grade standards</u>.

When this activity is not covered in the permit or if they don't have a permit for a waste operation:

"The EA will not normally take enforcement action against you if you are:

- capturing CO₂ at your AD plant to produce CO₂ that meets food and beverage or industrial grade standards;
- treating, storing and using CO₂ at your AD plant or elsewhere to produce CO₂ that meets food and beverage or industrial grade standards."

on the provision you meet all the conditions set out in the RPS.

This RPS will be reviewed by 1 September 2023

Household waste

- Recyclable household waste must be collected for recycling or composting – includes food and garden waste
- Food waste must be collected at least once a week.
- Food and garden waste may be collected together where—
 - (a) it is not technically or economically practicable to collect recyclable household waste in those recyclable waste streams separately or
 - (b) collecting recyclable household waste in those recyclable waste streams separately has no significant environmental benefit
- Business waste (non-domestic, industrial and commercial)
 - Requirement for food waste collections

"Developing the UK Emissions Trading Scheme (UK ETS)"

UK Emission Trading Scheme (UK ETS) Authority are seeking input on a large number of proposals to further develop the UK ETS. **Deadline: 17**th **June.**

Follows commitments in the Net Zero Strategy to consider expansion of the Emission Trading Scheme and alignment with Net Zero ambitions.

Since 1st January 2021 the UK ETS was established to replace UK Participation in EU ETS.

"Our goal is to make the UK ETS the world's first net zero consistent cap and trade market, and ensure it plays a crucial role towards achieving the UK's ambitious climate targets, including net zero greenhouse gas emissions by 2050."

UK Withdrawal Agreement also committed both parties to exploring the options of linking the UK and EU ETS.
